

Introduction

Each year the Colorado Balance of State (BoS) Continuum of Care (CoC) conducts a Point-in-Time (PIT) study on homelessness in Colorado's rural and non-metro counties. The PIT count has two major goals:

- Conducting an unduplicated count of individuals and families meeting the HUD definition of homelessness
- Capturing information about demographic characteristics, disabling conditions, and sub-populations related to homelessness



The CO BoS CoC covers 54 counties across Colorado.

The Balance of State CoC covers Colorado's 54 non-metro and rural counties. This includes all counties outside of metro Denver (Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, and Jefferson County), Colorado Springs (El Paso County), and Northern Colorado (Larimer and Weld County). During previous PIT counts, Northern Colorado had been a part of the Balance of State CoC. In 2020, they were designated by HUD as a separate CoC¹. This year the PIT count was held on the night of Tuesday, January 28th, 2020.

PIT counts are required to be conducted at least biennially by the United States Department of Housing and Urban Development (HUD) as a condition of applying for HUD homeless assistance funds. PIT counts are important because they provide data to quantify the scope of homelessness and help national, state, and local policymakers track progress towards the goal of ending homelessness.

Methodology

During even numbered years, the CoC conducts a sheltered PIT count. During odd numbered years, the CoC conducts both a sheltered and unsheltered PIT count. In 2020 the CoC conducted a sheltered PIT count of individuals and families across the state. The PIT Count was conducted in accordance with the HUD methodology guide² and the HUD data collection notice³ for the 2020 count. The survey instrument was developed by the Colorado Coalition for the Homeless (CCH), in consultation with their research partner, OMNI Institute.

For the **sheltered count**, the CoC counted all individuals and families “living in a supervised publicly or privately operated shelter designated to provide temporary living arrangements (including congregate shelters, transitional housing, and hotels and motels paid for by charitable

organizations or by federal, state, or local government programs for low-income individuals)” on the night designated for the count.

Regional PIT Coordinators throughout the state were responsible for planning and conducting the PIT count in their regions. CCH and the PIT Work Group provided training to all staff and volunteers, and Coordinators tailored additional trainings to meet their regions' specific needs. On January 28th service provider staff and volunteers administered the PIT survey forms to sheltered people experiencing homelessness throughout the Balance of State region. Sixteen counties participated in the 2020 PIT count.

Survey forms were collected and reviewed by CCH. CCH also provided OMNI Institute with a data extract from the Homeless Management Information System (HMIS). HMIS is a software application designed to record and store client-level information on the characteristics and service needs of people experiencing homelessness. Homeless assistance providers use HMIS to coordinate care, manage their operations, and better serve their clients. The HMIS extract OMNI received contained information for all clients who slept at Elko Shelter, Posada Motel Voucher Program, Posada Youth Outreach, The Bridge Shelter, and Abraham Connection Winter Shelter the night of the count. The HMIS data extract contained all the HUD required data elements, which meant that individuals included in the HMIS data did not need to complete a separate paper survey the night of the count.

OMNI completed data entry of all PIT survey responses. OMNI then carried out a thorough review of the PIT survey data and HMIS data extract to ensure that these two data sources could be combined. Once combined, the research team performed numerous checks to identify data entry errors, logic errors, and duplicate surveys. A total of 21 people were removed in the data cleaning process – 9 people were removed due to missing data⁴, 3 people were removed because the HUD-defined homeless status could not be determined, and 9 people were identified as duplicates and removed.

Data Definitions

In order to create this report, we used HUD-provided definitions to create several variables during the cleaning process. Table 1 contains a list of all variables that were created and their HUD definitions.

TABLE 1. VARIABLES CREATED

Variable	HUD-Provided Definitions
Household Types	
Households without children	Households with adults only. This includes households composed of unaccompanied adults (including unaccompanied youth age 18 to 24) and multiple adults (including households with multiple youth ages 18 to 24).
Household with at least one adult and one child	Households with (at least) one adult (including youth ages 18 to 24) and one child.
Household with only children	Households composed exclusively of persons under age 18, including one-child households, multiple-child households, or other household configurations composed only of children.
Youth Categories	
Parenting youth	A youth who identifies as the parent or legal guardian of one or more children who are present with or sleeping in the same place as that youth parent, where there is no person over age 24 in the household.
Unaccompanied youth	Persons under age 25 who are not presenting or sleeping in the same place as their parent or legal guardian or their own children.
Chronically Homeless	
Chronically homeless person	A person who: Is homeless and lives in a place not meant for human habitation, a safe haven, or in an emergency shelter; and Has been homeless and living or residing in a place not meant for human habitation, a safe haven, or in an emergency shelter continuously for at least 1 year or on at least four separate occasions in the last 3 years where the combined length of time homeless in those occasions is at least 12 months; and Has a disability.
Chronically homeless household	A household with at least one adult or minor head of household who is identified as chronically homeless. For households with more than one person, if one household member qualifies as chronically homeless, all members of that household should be counted as chronically homeless.

Interpreting PIT Data

The PIT count provides a snapshot of homelessness on a single night in January. Due to the transient nature of the population and the large geographic area of the Balance of State region, it is extremely difficult to capture all individuals and families experiencing homelessness. Because of this, the 2020 PIT count should be considered an underrepresentation of homelessness in the Balance of State region.

The PIT survey relies on self-reporting, which may impact the data. Individuals may be unwilling to disclose certain information or may not realize that they meet the criteria for a specific condition. Many of the disabling conditions included on the PIT survey are stigmatized, which may lead to underreporting.

Additionally, in the 2020 PIT count, extra caution should be taken when interpreting findings related to disabling conditions. Approximately eight people were not asked if they had either a brain injury or PTSD during the night of the count. Because of this, findings related to either of these disabling conditions should be considered an underestimate. Findings related to chronic homelessness should also be seen as an underestimate since disabling conditions are used to determine if a household is experiencing chronic homelessness.


Finally, changes in the homeless population year to year cannot be solely determined by examining PIT data. Each year changes are made to the PIT methodology and survey forms. Additionally, local conditions such as the number of participating agencies, the number of volunteers, and unseasonably warm or cool weather can impact both the number of individuals who seek shelter and the number of individuals included in the PIT count. We recommend using caution when comparing PIT count data over time. Increases or decreases in the homeless population may be due to methodology or changes in local conditions instead of true changes in homeless populations.

This map shows where in Colorado the 840 people experiencing homelessness were living during the 2020 PIT Count. **The counties with the largest share of people experiencing homelessness were Mesa County (26%), Bent County (22%), and Pueblo County (13%).**





Findings

Across the Balance of State (BoS) region, there were 840 homeless men, women, and children in 2020. HUD groups individuals into one of three “household types” – households without children; households with at least one adult and one child; and households with only children. Children are defined as people under 18. In 2020, the majority of households did not include children.

Demographics

This section contains demographic information about people experiencing homelessness the night of the Point-in-Time count and provides comparison data from the Colorado Balance of State (BoS) region. The BoS region data are from the 2018 Colorado Census. Throughout this section, only the demographic categories that matched between the Census and the PIT survey are included.


For the PIT survey, the head of household reported the age range for each household member - seniors (over age 55), adults (age 25-54), youth (age 18-24) or children (under 18). Because exact ages were not reported, average age cannot be reported. The majority of the people counted were adults 25 to 54 years old. Less than a quarter were children under 18.

The following graph compares the percentage of people who were children (age 0-17), youth (age 18-24), adults (age 25-54), and seniors (age 55+) in the BoS region and among people experiencing homelessness. Compared to the BoS region, people experiencing homelessness were more likely to be someone who is an adult or a senior.

People who identified as male outnumbered people who identified as female approximately two to one among those experiencing homelessness the night of the count.



In addition, the percent of people who identified as male was higher among those experiencing homelessness than the population in the BoS region. Please note that, the Census does not provide data on individuals who identify as transgender or gender non-conforming. Because comparison data for the general population was not available, these gender identities are not included in the figure below.

Approximately seventy-four percent of those counted reported their race as White and seventeen percent reported their ethnicity as Hispanic/Latino.

Compared to the population in the BoS region, people experiencing homelessness the night of the count were more likely to identify as non-White. American Indian and Alaskan Natives make up three percent of the region, but represent seven percent of those experiencing homelessness. Similarly, Black or African Americans, Native Hawaiian and Pacific Islanders, and people with multiple races make up a disproportionate amount of people experiencing homelessness. Whites and Asians are underrepresented among people experiencing homelessness.

FIGURE 3. RACE





FIGURE 4. ETHNICITY



Disabling Conditions and Sub-Populations

For each household member older than 18, the head of household reported the presence of serious mental illness, developmental disability, substance use disorder, HIV/AIDS, PTSD, brain injury, or chronic physical illness or disability. Over half of the adults experiencing homelessness had one or more disabling conditions. The most commonly reported disabling conditions were substance use disorder and chronic physical illness or disability.

Among the people counted the night of the PIT count, there were several small but significant sub-populations. Approximately one out of seven adults were currently fleeing domestic violence and about one in nine were veterans.





Conclusion

The 2020 Point-in-Time (PIT) count was a success due to the hard work and dedication of staff and volunteers across Colorado. It is extremely difficult to gather PIT data due to the large geographic area of the Balance of State region and the transient nature of people experiencing homelessness. The 2020 count should be considered a conservative estimate of the extent of homelessness in the region.

The 2020 PIT count provides valuable information about the people who were sheltered the night of the count. There are many takeaways from the data contained in this report including:

- 840 homeless men, women, and children
- 19% were families with children
- 20% were under the age of 25
- 60% reported at least one disabling condition
- 20% were chronically homeless
- 14% were currently fleeing domestic violence
- 11% were veterans

The 2020 PIT Report also highlighted racial and gender inequalities among those experiencing homelessness. People who identify as American Indian/Alaskan Natives, Black or African American, Native Hawaiian/Pacific Islanders or Multiracial make up a disproportionate amount of those experiencing homelessness compared to the population in the Balance of State region. People who identify as male were also overrepresented among those experiencing homelessness.

Additional data is included in the appendices. Appendix A includes information on household type, veteran status, individuals with one or more disabling conditions, chronic homelessness for each county and entitlement city. Appendix B provides a summary of the PIT data gathered for each county and entitlement city.

The 2020 PIT count provides required data for federal funding through the HUD Continuum of Care program. The data included in this report will be used by the Colorado Balance of State Continuum of Care and other stakeholders to inform additional outreach, service and program planning, and policy decision making as they work to address homelessness.
